as "G	SK") ar	nd (Name of Company;

		GSK operates certain kitchen facilities as described in this Agreement which, from , are available for rent; and
WHE	REAS,	User desires to rent those premises for the purposes herein contained;
		REFORE, in consideration of the mutual covenants and conditions herein contained, er agree as follows:

1.0	Servi	ces Provided
	1.1	GSK agrees to provide to the User access and use of the commercial kitchen facilities located at 406 Tompkins St, Orange, NJ 07050. The following equipment will be rented to members of the User who carry full ServSafe Certification or similar food handling certification:

- Stoves
- Conventional and convection ovens
- Mixers
- Fryers
- Sinks
- Food processors
- Blenders, etc
- 1.2 Small wares listed below will be located in a storage area available to all users within the space and are subject to availability (first come, first served).
  - Pots and pans
  - Stirring spoons, spatulas, and other utensils
  - Measuring cups
  - Mixing bowls, etc
- 1.3 Cold storage may only be utilized by the User when operating within the space via the refrigerators located in each kitchen space. Longer-term cold, frozen, and dry storage can be rented or provided through other contractual agreements; otherwise, all items must be removed when the User is not renting/using kitchen space. Terms associated with renting storage space(s) are set forth in a separate document.
- 1.4 GSK will attempt to maintain safe, ambient temperatures in the kitchen in all seasons via the kitchen's heating and cooling system. However, kitchens are a challenge to heat and cool; all reasonable accommodations will be made.

#### 2.0 Term

- 2.1 The term of the agreement shall be month-to-month if the User has a monthly payment package or per-shift if the User uses GSK hourly. Payment is required at the beginning of the month for the monthly payment plans. Hourly reservations will be charged after the completion of the shift.
- 2.2 GSK has all rights to terminate access to the facility at any time, with no notice to the User.
- 2.3 User shall be permitted to use the kitchen as set forth in this Agreement. The Kitchen is provided "as is" and "with all faults", and GSK makes no representation or warranty.

# 3.0 Kitchen Availability

- 3.1 The availability of the kitchen is at the sole discretion of GSK. It is anticipated that, under normal operating conditions, GSK will be available on a first-come first-served basis 24 hours per day, 7 days per week, 365 days per year. Emergency contact information is provided for urgent matters, particularly between 8pm and 8am, when emails and the main kitchen phone number are not checked.
- 3.2 Kitchen availability and bookings are exclusively scheduled by the User online, and all modifications and cancelations must be handled by the User. Access to the web calendar will be provided to the User after completing the onboarding process. By signing this Agreement, the User understands that GSK has the right to revoke availability when it requires full use of the shared commercial kitchen space to carry out its programs, and when use of the space is necessary to carry out its mission, or

for any reason as decided by GSK. Thus, the undersigned understands that dates and times of shared kitchen space operation are subject to change and availability.

## 4.0 Pricing

Pricing shall be set forth in a separate document and can be updated at any time, per the discretion of GSK. Kitchen rates are typically increased each year.

#### 5.0 Rent Payment and Space Utilization

- 5.1 The User, by signing the Agreement, understands that use of the shared commercial kitchen space will be forbidden unless rent has been paid or committed in advance via the Food Corridor website, as applicable, or if any payments are in arrears. User may only use the spaces they have reserved and rented. No walk-ins permitted.
- 5.2 There is a ten-minute grace period when renting kitchen space. If the User occupies the space more than ten minutes past their scheduled kitchen time and/or arrives more than ten minutes before their shift, they will be charged an additional hour's rent. Kitchen video cameras will be used to determine length of shift, kitchen spaces used, etc; Users will be billing according to the spaces and equipment they use.
- 5.3 User will pay rent and all other payments and fees exclusively through GSK's third party booking and billing system which:
  - Adds a 4% service fee to invoices when using a credit card.
  - Adds a 2% service fee to invoices when using an automated clearing house (ACH).
- 5.4 The User must have an account in good standings to book and utilize time at GSK. Should any User's account be in arrears for an amount greater than that of the User's security deposit, the User's account shall be suspended until the amount in arrears is paid in full. Should any payment remain uncollectable after three attempts at collecting payment, the User's account will be suspended.

# 6.0 Security Deposit

By signing the Agreement, the User agrees that security deposit is collected and retained by GSK, in a non-interest bearing account, to pay and recover loss, cost, damage or expense, while the User leases space in GSK. To the extent not necessary to cover such loss, cost, damage or expense, this security deposit shall be returned to the User within 30 days after the expiration of the Agreement.

# 7.0 Improvements and General Administration

- 7.1 GSK reserves the right to make improvements at any time to the shared commercial kitchen space that may include, but not limited to, making changes in rules of operation, accessibility, User identification and security procedures, and support services.
- 7.2 User shall not injure, mar, alter, or in any way deface the premises and shall not cause or permit anything to be done whereby the premises shall be in any manner injured, marred, altered or defaced and will not drive, or permit to be driven, nails,

hooks, tacks or screws into any part and will not make or allow to be made any alterations of any kind therein.

- 7.3 User agrees that all employees, agents, participants and/or guests of the User are under the direct and complete supervision and control of the User. As such, User is liable for all damages resulting from employees, agents, participants and/or guests utilization of the facilities and services provided by GSK. GSK assumes no responsibility for loss or theft of personal property or damage to personal property of User or any of its employees, agents, participants and/or guests.
- 7.4 GSK may be able to provide kitchen documentation for requesting parties to verify that a specific User is utilizing commercial kitchen space. This will be determined on a case-by-case basis. Certifications are not provided directly to User but rather to the verified requestor. Documents are only provided by email. Ten business days are required for providing documentation.

# 8.0 Space Utilization Revocation

GSK has the right to revoke time periods available for rent to the User when GSK requires the full use of the shared commercial kitchen space to properly carry out its mission, or should GSK decide for any reason to revoke access to the space for a single shift or for perpetuity for any reason. Such notice will be given with 48 hours notice, when possible.

## 9.0 Liability of User

- 9.1 GSK shall not be liable for any damages to either person or property sustained by User or its personnel or by any third party arising in any way; The User's use, operation, or occupancy of GSK or any portion thereof; or the sale, distributions, or use of any product that is produced at GSK. This includes any items or products stored in cold, dry, or frozen storage, and User should take care to obtain insurance that covers any potential associated loses. GSK does not use a backup power generator and User should remain attentive to the potential for power outages and how those may impact their operations or storage.
- 9.2 The User agrees to indemnify, defend and hold harmless GSK and its employees from any and all claims, cost and liabilities arising from, or in connection with damages or injuries to persons (including death) or property arising in any way from: The User's use, operation or occupancy of GSK or any portion thereof; or the sale, distributions or use of any product that is produced at GSK.

## 10.0 User Responsibilities

10.1 Employees

The User shall be solely responsible for its employees' safety and their actions. No more than three (3) people, including the User, will be permitted to operate in GSK per each reservation. Should additional persons be onsite during the shift, an additional fee will be charged. The User must be present at all times. All members of the User's party must be 18 years old or older; no one under the age of 18 is permitted in the facility at any time.

#### 10.2 Attire

The User and all employees must wear anti-slip, closed toe shoes, and hat/hair covering. Attire in kitchen must meet ServSafe and other food handling requirements at all times.

#### 10.3 Licenses and Documents

The User will maintain at all times all necessary licenses and coverages to properly own and operate a business in the State of New Jersey or New York. A New Jersey food handler's license and insurance certificate must also be provided and kept current. It is the User's responsibility to upload all documents to their account on the Food Corridor. User accounts will be deactivated up to two weeks in advance of document expiration dates and only be reactivated once all documents are current.

#### 10.4 Public and Product Liability Insurance

The User will maintain at all times a minimum both product liability insurance and general liability insurance with GSK listed as additional named insurance in each case. Proof of such insurance must be provided to GSK before any use of the facility will be permitted. GSK may, at any time, require the User to show proof of the required insurance.

## 10.5 Unlawful Use

The User shall not use or permit GSK premises or any parts thereof to be used by any person in violation of any municipal, county, state, or federal ordinances or law, or in any manner disruptive to GSK. Such behavior shall include, but not limited to, theft, fighting, or consumption of alcohol on the premises.

## 10.6 Smoking

Smoking of any substance – legal or illegal – is not permitted anywhere on the premises. This includes cigarettes, e-cigarettes, vapors, marijuana, and any other item not listed here.

#### 10.7 Access

The User will be given an access code and a key to the facility. The User, by signing this Agreement, agrees to keep their code confidential, and that the code is kept with the User. No one unknown to the User and without their own access code should be admitted to the premises at any time by the User.

#### 10.8 Inspection

GSK shall have the right to inspect GSK at any time during the User's session and reserves the right to enter whenever it deems to be necessary.

#### 10.9 Board of Health Inspections

The User shall submit to Board of Health inspections as often as the required and pay any associated fees as required by the Board Health. The User agrees to cooperate with the Department of Health and maintain a Food Handler's License.

#### 10.10 Food Equipment Safety and Sanitation

All Users will be required to earn ServSafe certification. User is also responsible for maintaining proper food handling procedures, cleanliness, and safety of work stations and food storages (dry, cold, and frozen) whenever at GSK. All spaces are expected to be kept and left professional, clean, and safe at all times.

10.11 Procedures, Policies, and Regulations

By signing the Agreement, the User agrees to comply with all provisions listed here as well as all posted or distributed procedures, policies, or regulations of GSK.

10.12 Products

Only those items that will be used for human consumption will be deemed appropriate for manufacturing at GSK, or otherwise noted.

10.13 Fryer Use

User is responsible to provide their own cooking oil for the fryer(s). If User provides the empty container, GSK Staff will drain the oil back into the container once cooled and clean the fryer. The User is responsible for the collection of used oil no longer than 24 hours after the completion of the reservation; otherwise the used oil will be recycled.

10.14 Photo and Video Release

The User grants permission to GSK and its agents and employees the irrevocable and unrestricted right to reproduce the photographs and/or video images taken of them for the purpose of publication, promotion, illustration, advertising, or trade, in any manner or in any medium. The User hereby releases GSK and its legal representatives for all claims and liability relating to said images or video. The User grants permission to use statements given during an interview or workshop, with or without attribution, for the purpose of advertising and publicity without restriction. The User waives right to any compensation.

10.15 Music

Music is not permitted at any time while working in the kitchen.

10.16 Contact Info

The primary method of official communication from GSK is electronic mail. The email address listed in the User's electronic account will be the email address of record and the one with which GSK will provide all kitchen updated. It is the User's responsibility to update GSK of any and all contact info changes and stay apprised of any and all kitchen policy changes.

10.17 Fines for Fire Alarm

Should the User create enough smoke and/or heat to trigger the fire alarm and the Fire Department is called, the \$1,000 fine will be passed through to the User.

10.18 Fines for Parking in Loading Zone

Should the User leave their vehicle in the loading zone longer than 15 minutes and block the waste management vehicles, the \$150 fine from the disposal company will be passed through to the User.

#### 11.0 Termination

In the event that such a violations of standards, or a breach, or failure to keep or perform to the standards laid out in the Agreement the User must act immediately to correct the problem when notified. If the User fails to take corrective action immediately, GSK may take such action itself and the User shall reimburse GSK for all costs of such action. GSK also has the right to terminate the rights of the User if it deems fit after such action had to be undertaken.

#### 12.0 Cancellation

- 12.1 In the event that the User wishes to terminate their monthly payment plan, the User must notify GSK thirty (30) days in writing. The notice shall be sent to Kris Ohleth via email, whose contact information is provided on the following page.
- 12.2 In the event that the User cancels time booked in the space less than 72 hours before the reservation, the User will be charged 50% of the cost associated with the time booked. Requests to change bookings within 72 hours will not be honored.

#### 13.0 General

- 13.1 The User acknowledges that it has read this agreement, understands it, and agrees to be bound by its terms. The User also agrees that this agreement constitutes the entire agreement between the parties.
- 13.2 The User agrees to respect the rights and property of GSK other users.

## 14.0 Applicable Laws

- 14.1 User agrees to comply with all applicable laws, ordinances and rules of the State of New Jersey and the United States, and to pay all taxes imposed by law in connection with its use and occupancy.
- 14.2 User warrants that it will occupy Facility and conduct its activities in a manner that complies with all applicable provisions of the Americans with Disabilities Act (ADA) and the Rehabilitation Act. User agrees to indemnify GSK, its principals, agents, and employees from any claim, losses, suits, proceedings, damages, or liabilities, including attorney's fees, that arise out of or based on the grounds that the facility or services provided the user failed to comply with the applicable provisions of the ADA or any other applicable law. User agrees to reimburse GSK for any legal or other expenses incurred by GSK in connection with investigation of defending against such claims, losses suits, proceedings, damages, or liabilities, as and when such expenses are incurred, GSK reserves the right to settle any claim, proceeding, or suit at any time.

## 15.0 Indemnification and Waiver of Liability

GSK shall not be liable to use, or to any agent, employee, servant, guest, or invitee or User, and User shall indemnify, defend, and hold GSK harmless from and against any all fines, suits, claims, demands, losses, liabilities, actions, and costs (including attorney's fees) arising from: any injury to person or damage to property caused by any act, omission, or neglect of user, its agents, employees, servants, or invitees; User's use of the facility under this agreement or the conduct of User's business; any activity, work, or thing done, permitted, or suffered by external User under this agreement; or any breach or default in the performance of any obligation on GSK's part to be performed under the terms of this agreement.

#### 16.0 Non-Assignment

User shall not assign or transfer this User Agreement to anyone at any time. Kitchen or storage space shall not be shared or sublet for any reason, at any time.

# 17.0 Governing Law and Jurisdiction

- 17.1 This Agreement shall be governed by and construed in accordance with the laws of the State of New Jersey.
- 17.2 If any dispute arises out of or relating to this agreement, in order to resolve it in an efficient and cost-effective manner, it will be subject to arbitration in the State of New Jersey pursuant to the rules of the American Arbitration Association. The decision of the arbitrator will be final and enforceable in any court of competent jurisdiction.
